After the agenda items were discussed, Hon'ble HRM expressed the concern over the flagship proramme of MHRD on rationalising curriculum/ syllabus/ subject contents for class I to class XII with the objective of all round development of students that will be applicable from next academic session 2019-20 and directed NCERT to submit a proposal for constituting a committee and propose the names of prominent experts / educationists who have earlier contributed in making of textbooks and non-official members of Executive Committee who can contribute in the committee. Hob'ble HRM also desired that the non-official members of Executive Committee may also be involved in maximum committees of NCERT.

Hon'ble HRM further directed NCERT to make the cost analysis of NCERT textbooks in consultation with JS & FA, MHRD to decide the options to increase the price of textbooks, to set competitive rate of commission to vendors/retailers, etc.

The Committee ended with the vote of thanks to the Chair.
