Minutes of the 46th Meeting of Establishment Committee

The 46th Meeting of the Establishment Committee of NCERT was held on April 04, 2018 at 3:00 p.m. in the Conference Room, 1st Floor, Zakir Hussain Block, NCERT, Sri Aurobindo Marg, New Delhi- 110 016 under the Chairmanship of Prof. Hrushikesh Senapaty, Director, NCERT. Director, NCERT welcomed all the members of the committee after which the agenda items were taken up by Secretary, NCERT with the permission of the Chairperson.

Item No.1: Confirmation of the proceedings of the 45th Meeting of the Establishment Committee held on 13th June, 2017.

The minutes of the 45th Meeting of Establishment Committee held on 13th June, 2017 were confirmed.

Item No.2: Action Taken Report on the Minutes of the 45th Meeting of the Establishment Committee of the Council held on 13th June, 2017.

The committee noted the action-taken.

Item No.3: To consider and approve the proposal regarding amendment of recruitment rules for the post of Lower Division Clerk, Assistant Program Coordinator, etc.

Secretary, NCERT informed that after notification of Recruitment Rules for non academic post of the NCERT vide notification No. F 1-4/2017-EC/297 dated 28-07-2017, various representations from the non-academic employees have been received and accordingly a committee under the Chairmanship of Dean (R) was constituted to look into the grievance of the employee of the Council.

After detailed deliberations, the Establishment Committee approved the following recommendations of the aforesaid Committee:-

1) Relaxation of educational qualification prescribed for the post of LDC under direct recruitment

The Establishment Committee agreed to the proposal and recommended that educational qualification of Class X will apply for the post of LDC for departmental candidates for promotion under promotional quota as well as departmental candidates competing under limited departmental competitive examination quota.



2) Age relaxation to departmental candidates competing under Direct Recruitment quota

The recommendations of the aforesaid committee were not fully agreed by the Establishment Committee and reommended that only 'One Time No Age Bar Relaxation' may be given to NCERT employees competing under Direct Recruitment quota.

3) Assistant Programme Coordinator:

The Committee deferred the recommendations of the above item.

Item No.4 To consider and approve the proposal regarding medical reimbursement requests from retired pensioners, residing outside Delhi/NCR and getting Fixed Medical Allowance.

The Committee discussed the matter in detail and after deliberations; the Committee was of the view that NCERT may explore the procedure followed in other organisations may be obtained and a comprehensive proposal may be prepared and put up before the Committee so that a concrete decision could be taken.

Addl. Item No.1: To consider and approve the proposal for amendment of RRs for the post of Headmaster in D.M. Schools of RIEs—reg.

After detail deliberations, the committee deferred the item.

Addl. Item No.2: Revision of Pay Scales of Academic Staff of NCERT on the recommendation of 7th Central Pay Commission.
