
Major Harsh Kumar, Secretary, NCERT extended a warm welcome to the Committee members, after which the agenda items were taken up with the permission of the Chair.

Item No.1: Confirmation of the Minutes of 140th Meeting of the Finance Committee held on 05.12.2019.

The minutes were confirmed.

Item No. 2: Action taken on the Minutes of 140th Meeting of the Finance Committee held on 05.12.2019.

While discussing the confirmation of the minutes, Shri Shobhit Gupta, Director (Finance), Ministry of HRD pointed out under Item No. 2 of the minutes of 140th Meeting wherein it has been mentioned that from the next year Audit Annual Accounts alongwith SAR Audit Notes may be placed in the Finance Committee so that Finance Committee make recommendations thereon to the Executive Committee. In this regard CAO NCERT informed that the work on the Accounts are yet to be completed and will be reported in the next meeting of the Finance Committee.



The Director, (Finance) also pointed out under item number 3 of the minutes regarding enhancement of upper limit of sale price of NCERT textbooks for Classes I to VIII from Rs.60/- to 65/- wherein the Committee desired that the report of the Committee constituted to review the cost of textbooks in accordance with their relevance and purpose be submitted within three months and the time is already over of six months.

Prof. A.K. Rajput, Head, Publication Division informed that the Committee is formed and the Committee is working on all the aspects of revision of textbook and prices. Due to COVID-19 pandemic, the meetings of Committee could not be held. Once it is approved by the Committee, it will be placed before the next meeting of Finance Committee along with report of the Committee.

The Committee also recommended that the detailed proposals with regard to item number 3, 4 & 5 which could not be done due to COVID situation, be submitted in the next Finance Committee with full details and financial implications.

Item No 3. Procurement of additional requirement of 900 MTs of 220 GSM Art Card cover paper to meet the fresh requirement for the printing of General Publications for the state of Uttar Pradesh & Haryana. - Regarding

Secretary NCERT placed the Item for Procurement of 900 MTs of Art Card of 220 GSM in sheets conforming to BIS specification 4658:2019 with latest amendments, if any, for cover printing through GeM. The approximate expenditure of Art Card based on the current price of Rs 64.80 per kg (as per last purchase rate) works out to be Rs. 5,83,20,000/-. During detailed deliberations, the representative of JS&FA, Director (Finance) submitted the observation that there should be no pendency in supply of the procured item. Thereafter Prof. A.K. Rajput explained the agenda item in detail
