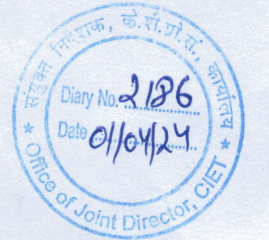

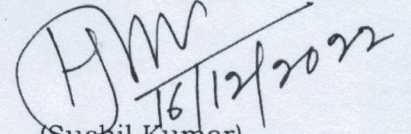

OFFICE MEMORANDUM

Subject: Revised Pay Levels as per recommendations of the Seventh Central Pay Commission - Issue of instructions on revision in minimum qualifying service required for promotion - regarding

The undersigned is directed to refer to this Department's OM No. AB.14017/13/2016-Estt.(RR) dated 9.8.2016, wherein all Ministries/Departments were advised to amend the Service Rules and Recruitment Rules by substituting the existing Pay Band and Grade Pay with the new pay structure i.e. "Level in the Pay Matrix", as per the recommendations of 7th CPC and the CCS (Revised Pay) Rules 2016 issued by Department of Expenditure vide Notification dated 25th July, 2016, straightaway without making a reference to the Department of Personnel and Training (DOP&T)/Union Public Service Commission (UPSC).

2. Attention is invited to this Department's OM No AB.14017/61/2008-Estt. (RR) dated 24.3.2009, which was issued following implementation of the recommendation of the 6th CPC, indicating the revised minimum qualifying service required for promotion, to be prescribed in the Service/Recruitment Rules, as per the revised pay structure introduced as per recommendations of the 6th CPC and accepted by the Government. The said OM was issued in the context of earlier instructions issued vide DOPT OM No. AB.14017/2/97-Estt. (RR) dated 25.5.1998, prescribing the minimum qualifying service as per 5th CPC pay scales.

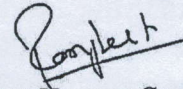
3. Instructions revising the minimum qualifying service required for promotion, as per 7th CPC Pay Matrix/Pay Levels, have not been issued so far and proposals for framing/amendment of RRs/Service Rules are still being considered, based on the requirements prescribed in OM dated 24.3.2009. Though the levels in Revised Pay Matrix as per 7th CPC Pay Matrix, generally correspond to the pre-revised Grade Pays/Pay Scales (6th CPC), however, a need was felt to prescribe minimum qualifying service for promotion as per Pay Levels in the Revised Pay Matrix.

4. Therefore, the instructions issued vide DOPT OM dated 24.3.2009 has been reviewed, in consultation with the UPSC and with the approval of the competent authority it has been decided to revise the norms prescribing minimum eligibility service required for promotion, as per 7th CPC Pay Matrix and Pay Levels. The revised norms for minimum eligibility service for promotion have been indicated in the table at Annexure-I.

5. Therefore, the revised norms prescribing minimum eligibility service required for promotion, as per 7th CPC Pay Matrix and Pay Levels, given in Annexure-I, may be incorporated in the Recruitment Rules/Service Rules by making suitable amendments. All the Ministries/Departments are, therefore, requested to effect necessary amendments to the Recruitment Rules/Service Rules, in this regard, after following the due procedure.

6. The Recruitment/Service Rules are of statutory nature. Moreover, any amendment in these Rules generally have prospective effect. Therefore, in terms of para 3.1.3 of DoPT OM No. AB.14017/48/2010-Estt. RR dated 31.12.2010, wherever required, suitable 'protection clause' may be incorporated in the amendment proposed in the Recruitment/service Rules, providing for retention of existing eligibility service for existing incumbents holding the feeder posts on regular basis, where the eligibility service for promotion prescribed in the existing rules is being enhanced and where the change is likely to affect the promotion of these incumbents.

7. Ministries/Departments may initiate action to complete the review in this regard and furnish necessary amendment proposals to the DOPT and the UPSC in the case of Group A and Group B posts within six months from the date of issue of this Office Memorandum.

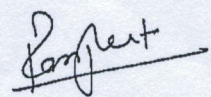

MINUTES of 110th EXECUTIVE COMMITTEE MEETING
THROUGH CIRCULATION

The 110th meeting of the Executive Committee (EC) of the National Council of Educational Research and Training (NCERT) was convened through Circulation amongst esteemed members of the Executive Committee on 27.02.2024, under the Chairpersonship of the Hon'ble Minister of Education, Government of India and *ex-officio* President, NCERT.

The list of the Members of Executive Committee is attached as *Annexure 1*.

Following are the Item-wise details of the Agenda, which were circulated among the esteemed members for their approval/ratification:

1. **Items Recommended by the Establishment Committee of NCERT made in its 49th Meeting held on 27 October 2022.**

The 110th EC approved/ratified the following recommendations of the 49th Establishment Committee of NCERT:

- 1(a). The Committee ratified the 'List of subject experts for recruitment and promotion under CAS of Academic Staff of NCERT' recommended by the 49th Establishment Committee.

Subsequently the Constitution of the proposed Selection Committees included the names of the subject experts from the Pool of Experts thus prepared, got approval of the Hon'ble Minister of Education.

The Representative of the Ministry reiterated the recommendation of the 49th Establishment Committee of NCERT that the confidential nature of the List needs to be maintained and therefore as proposed by the Director, NCERT, the members of the Committee could peruse the List separately in the Office of the Director, NCERT and either make any suggestions or recommend the same within the stipulated time of 2 days as discussed. Accordingly, the list has been perused and signed by most of the members.

- 1(b). The item 'Need-Based changes in regulations, 2018 of UGC on minimum qualification for recruitment and promotion of faculty of NCERT under CAS' approved by the EC. In this matter, one of the Member of E.C., Prof.

Anil Sahasrabudhe observed that approval of UGC may also be sought along with that of the Ministry.

In this regard, it is clarified that UGC vide letter No.F.1-10/2022(PS/Misc.) dated 23 September 2022 has agreed to the Need-Based Changes for promotion under CAS as per UGC Regulation 2018, in view of the difference in mandate and nature of work of NCERT in comparison to Universities.

- 1(c). Approved the item for implementation of Office Memorandum No.F.AB-14017/4/2021-Estt.(RR) dated 20/09/2022 regarding *revision of minimum qualifying service required for promotion as per 7th CPC recommendation* in the Council from the prospective effect i.e. 01/07/2024 and the interest of the serving employees would be taken care of while implementation of the OM.

In this matter, the representative of the Ministry approved the item subject to the following conditions:

“NCERT has been extending the benefits of the 7th CPC and the CCS (Revised Pay) Rules, 2016 to its employees with effect from 1.1.2016. Recently, the DoPT has notified some revised norms prescribing minimum eligibility service required for promotion vide its Office Memorandum F.No. AB-14017/4/2021-Estt.(RR), dated, 20/9/2022 with reference to the 7th CPC Pay Matrix and Pay Levels.

It is stated that DoPT OM dated 20.09.2022, inter-alia, provides that the revised norms prescribing minimum eligibility service required for promotion, as per 7th CPC Pay matrix and Pay Level may be incorporated in the Recruitment Rules/Service Rules by making suitable amendments. Any amendments in these rules generally have prospective effect.”

The recommendation of the Ministry are accepted & benefit of promotion to NCERT employees shall be given as per the DoPT OM dated 20-09-2022. NCERT shall also expedite the amendment of minimum service eligibility conditions in RRs, wherever required.

2 Recommendations of the Establishment Committee of NCERT made in its 50th Meeting held on 30 January 2023.

In view of the urgent need, more names were included to the *pool of experts* in different subject areas for direct recruitment and promotion of Academic Staff of NCERT under the Career Advancement Scheme (CAS). In the present matter, the representative of the Ministry approved the item subject to the conditions to include additional names to the pool of experts, it was advised to follow the same procedure as followed while preparing the list experts on previous occasion. Regarding the query of the Ministry, whether approval of the Hon'ble Minister of Education was obtained in the matter, it is clarified that all the Selection Committees propose by NCERT included the names of Subject Experts from the Pool of Experts as prepared, finalized and ratified by the Establishment Committee, have been approved by the Hon'ble Minister of Education and President, NCERT. Thus, all the experts invited for the Selection Committees from the Pool of Experts has the approval of the Hon'ble Minister of Education.

EC ratified the item.

3. Recommendations of the Finance Committee of NCERT made in its 147th Meeting held on 17 July 2023.

The EC approved/ratified the following recommendations of the 147th Finance Committee (FC) of NCERT:

- 3(a). The Committee approved the recommendation of the 147th FC regarding Budgetary Allocation for the financial year 2023-24 prepared on the basis of Grant-in-Aid (GIA) approved by the Ministry/Government at Budget Estimate (BE) Stage under Salary, Revenue [GIA(i)], Capital Heads and NER.

In the present matter, the representative of the Ministry approved the item subject to the conditions to increase its internal revenue generation to meet the Council's additional requirements, if any, apart from the budgetary allocations prepared on the basis of the Grant-in-Aid (GIA) approved by the Ministry/Government at the Budget Estimate (BE) stage for Salary, Revenue [(GIA) (i)], Capital Heads and NER as suggested by the Joint Secretary (Institutions), MoE being member of the committee of EC.

- 3(b). The Committee approved the Annual Accounts of NCERT for the year 2022-23 and the representative of the ministry approved the item subject to the

conditions that as per Rule 70(iv) and Rule 71 of Rules of Council, the Annual Report and Audited Annual Accounts of NCERT, after approval of Executive Committee/General Council of NCERT, are to be laid in both the houses of Parliament within nine (09) months of closing of the accounting year. NCERT has submitted its Annual Accounts on 19.02.2024 and the last Parliament Session of Parliament *Sine-die* on 10.02.2024. Hence, the Annual Account and Annual Report of NCERT for the FY 2022-23 could not be laid on the table of the house. NCERT is advised to adhere to the timeline.

3(c). The Committee approved the proposal for enhancement of (i) consolidated remuneration/TA/DA/Leave/Tenure of project staff working in various PAB and PAC-approved programmes of NCERT as per details mentioned at page 157 to 160 of EC Agenda, (ii) Honorarium to Resource Persons/Experts in Workshops, Training/Orientation programmes, Seminars/Conferences etc. from Rs.2,500/- per day to Rs.3,000/- per day, (iii) Experts invited to give lectures in specialised areas in NCERT's programmes or for consultation purposes from Rs.2,500/- per day to Rs.3,000/- per day, (iv) Honorarium to Honorary Directors (if the programme is more than 5 days' duration) from Rs.2,500/- per day (with a maximum of Rs.15,000/-) to Rs.3,000/- per day (with a maximum of Rs.18,000/-), and (v) Conveyance charges to local participants/Experts from Rs.1,000/- per day to Rs.1,500/- per day or actual payment on receipt (whichever is less).

3(d). The Committee approved the proposal for *Revision of Honorarium for External Experts for Evaluation of ERIC Project Reports from Rs. 1000/- to Rs. 3000/- per report* taking the merits of the proposal into consideration.

3(e). The Committee approved the proposal for *Revision of Honorarium for External Experts for Review of Research Papers of Indian Educational Review (IER) Journal* from the existing rate of Rs.500/- per paper to Rs.1000/- per paper.

3(f). The Committee approved the proposal for *enhancement of remuneration of contractual staff engaged in NCERT against vacant administrative, accounts and technical posts as per 7th CPC* as the existing remuneration is being paid to the contractual staff as per 6th CPC since 2015. As per the advice of the Ministry, the specific recommendations of the 147th Finance Committee is reproduced as under:

From the next year onwards, Dearness Allowance as on 1st July of the year will be taken into consideration for determining the total emoluments and then fixing the remuneration of contract employees by rounding off to the lower thousand, as done above. Further, in case the retired employee apply for these post and are selected, their emoluments will be fixed as per GoI norms.

3(g). The Committee approved the following 13 recommendations of the 46th Building and Works Committee which were subsequently also recommended by the 147th Finance Committee Meeting held on 17/07/2023:-

1. Construction of a Light Weight Structure on the Roof of the Director's Bungalow at NCERT Campus, New Delhi with an estimate of Rs.55,20,900/-
2. The item for Construction of a Central Administrative Building at NCERT Campus, New Delhi was recommended by the 46th B&W Committee with the advice to place proposal along with its cost estimate before the Delegated Investment Board (DIB) for further recommendation and thereafter for approval of the Executive Committee. The same item was again placed before the 47th B&W Committee and approved in principal with some observations.
3. Supply Installation Testing and Commissioning (SITC) of 300 KLD Capacity Sewage Treatment Plant(STP) at NCERT Campus with an estimate of Rs.3,68,71,600/- including 3% contingencies.
4. Construction of 2 (two) STPs (Sewage Treatment Plants) at RIE, Bhopal with a composite estimate of Rs.2,02,38,300/-.

5. Construction of 1 (one) Borewell & Water Harvesting Structure at RIE, Bhopal with an estimate of Rs.15,35,100/- including 5% contingencies.
 6. Construction of the First Floor of Block 'B' (Vertical Extension) of PSSCIVE, Bhopal with an estimate of Rs.8,02,52,600/- including contingencies.
 7. Construction of an Automobile Workshop Shed at PSSCIVE, Bhopal with an estimate of Rs.31,40,200/- including 5% contingencies.
 8. Construction of Vermi compost Beds/Pits for Agriculture at PSSCIVE, Bhopal with an estimate of Rs.18,57,600/- including 5% contingencies.
 9. Construction of Smart Mini Theater – Lecture Rooms at RIE, Ajmer with an estimate of Rs.5,03,89,000/- including 3% contingencies.
 10. Extension of Tilak Hostel at RIE, Ajmer with an estimate of Rs.6,31,33,000/-
 11. Construction of 2 (two) Indoor Badminton Courts at RIE, Ajmer with an estimate of Rs.1,28,27,000/-
 12. Construction of 2 (two) Tennis Courts with Chain-Link Enclosure at RIE, Ajmer with an estimate of Rs.86,25,600/-
 13. Construction of a New Overhead Water Tank of 2,50,000L Capacity at RIE, Mysore with an estimate of Rs. 1,49,55,431/-
- 3(h). With regard to No.3(g)(2) above, the Executive Committee approved the recommendation regarding *Construction of Central Administrative Building* of the 47th Building and Works Committee which was subsequently also recommended by the 147th Finance Committee Meeting held on 17/07/2023, for an amount of Rs.81.99 cr.(PE).

The Committee approved the proposal for enhancement of seating capacity of the Construction of Auditorium at NCERT Campus from 800 to 902 due to addition of basement to meet out statutory requirement of DUAC with a revised cost of Rs.57.84

crore subject to approval of Revised Cost Estimate (RCE) Committee and recommendation by the 148th Finance Committee.

As per comments of representative of MoE, the Revised Cost Committee (RCC) on 04.03.2024, after detailed deliberation recommended the proposal with the enhanced cost of Rs. 57.84 Crores for Construction of Auditorium at NCERT Campus, New Delhi.

4. Actions Taken on the Minutes of the 109th Meeting of the Executive Committee (EC) of NCERT held on 12 September 2022 & Confirmation of its Minutes

- i. 110th EC confirmed the Minutes of the 109th EC meeting and its Action Taken thereon.
- ii. With regard to item 2 of the 109th EC minutes, the NCERT is advised to expedite the matter for submitting the proposal for fulfilling conditions as suggested by Deptt. of Higher Education w.r.t. Letter of Intent issued on 31.8.2023 regarding Grant of 'Deemed-to-be-University' Status to NCERT in the *De Novo Category* as per observation of the MoE representative.
- iii. With regard to Action Taken on 4.7(ii) of the 109th EC Minutes, 110th EC ratified the approval given by the Hon'ble Minister of Education and President of the NCERT in his capacity as the Chairperson of the EC to approve the Additional Agenda Item regarding paper procurement for printing of textbooks for the Session 2024-25 which was recommended by the 147th FC meeting held on 17-07-2023.
- iv. In pursuance of the decision taken in the 109th EC Meeting, the Council has advertised 347 vacant Non-Academic Posts vide Advt. No.11-4/2019-20/E.III/R.II to fill-up under Direct Recruitment. The Selection Process to fill-up 290 vacancies posts have been completed with the approval of the Hon'ble Minister of Education and President of the NCERT in his capacity as the Chairperson of the EC. Offer of appointments to the selected candidates is being sent after completion of formalities. In order to fill-up the remaining vacancies under Direct Recruitment, similar exercise would be done in the coming weeks.

In addition to this, the Council has taken up the matter to fill-up 72 Non-Academic Posts simultaneously with the Ministry for seeking approval to fill-up these vacancies on the basis of 'Saving and Matching Scheme' as per the
