

Sub: Allotment of CWG Flats at concessional rate

Sir,

Delhi Development Authority has approved a Scheme for allotment of three bed room flats at CWG Complex, near Akshardham Temple, New Delhi at concessional rate to Govt. Bodies, PSUs and Corporations of Central and State Governments.

Authority is having a stock of around 140 ready built-up three bed room flats as per details given below :-

Locality	Category	Tentative cost of flat	Plinth area (in sq.m approx)	Number of flats
CWG Flats near Akshardham Temple, New Delhi	Three Bed Room	Rs. 3.92 to Rs. 4.48 crore excluding conversion charges and 2 car parkings.	175-200	140

Some of these flats have been earlier sold at the rate of Rs. 3,41,210/- per sq.m. However, Authority has now approved concessional rate which is Rs. 2,24,000 per sq.m. This rate is excluding conversion charges and cost of car parkings. Conversion charge per flat is Rs. 11,130/- per sq.m and cost of two car parkings is Rs. Fourteen lakh. The scheme will be on first come first serve basis.

It is requested to give wide publicity for the scheme among departments/ organisations/ corporations under the ministry and confirm consolidated requirement of flats to DDA at the earliest so that further course of action for allotment of flats may be taken by DDA. DDA may provide further details as may be required.
