

G.S.R. 42.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the National Council of Educational Research and Training (Director) Recruitment Rules, 2009, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Director in the Ministry of Human Resource Development, Department of School Education and Literacy, in the National Council of Educational Research and Training, namely :—

1. Short title and commencement.—(1) These rules may be called the National Council of Educational Research and Training (Director) Recruitment Rules, 2010.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and Pay Band and Grade Pay/Scale of Pay.—The number of post, its classification and Pay Band and Grade Pay/Scale of Pay attached thereto, shall be as specified in columns (2) to (4) of the Schedule.

3. Method of recruitment, age limit, qualifications, etc.—The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (14) of the said Schedule.

4. Disqualification.—No person,—

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the aforesaid post:

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

By deputation or short-term contract on tenure basis. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of Central Government shall ordinarily not exceed five years or up to the age of 62 years of the candidate or until further orders whichever is earlier.

Officers of the Central Government or State Governments, Autonomous Organizations, Universities holding analogous posts on regular basis or in the scale of pay of Rs. 37400-67000 (PB-4) with Grade Pay Rs. 10000 possessing the following qualifications :—

Essential :

- (i) Ph.D.; and
- (ii) experience of working as professor in the State or Central Universities or educational institutions of State or Central Government.

Desirable :

- (i) First Class or equivalent degree at the level of Post Graduation;
- (ii) Master's or Ph.D. degree in education;
- (iii) Impressive academic credentials and experience in the field of educational research and training;
- (iv) Publications in journals, especially journals of education of national and international repute;
- (v) Administrative, organizational and leadership capabilities besides wide ranging interest in regard to conduct of research on different aspects of school education.
