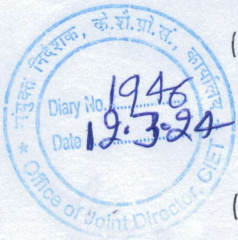
Sub: Extension of Credit/Cashless facility to the NCERT's retired/serving employees covered under from CGHS facility in Emergency/Hospitalization/Inpatient treatment at CGHS rates – reg.

Sir,

This is in reference to request on the subject mentioned above and to accord approval for availing medical facility "IN EMERGENCY/HOSPITALIZATION/IN-PATIENT TREATMENT" and OPD TREATMENT (Tests/Investigations) in accordance of Office Memorandum No.Z.15025/117/2017/DIR/CGHS/EHS dated 10.12.2018 regarding simplification of referral system under CGHS at CGHS rates on credit/cashless basis to the serving/retired employees of NCERT and their family members, residing in Delhi/NCR only w.e.f.04.03.2024 on the following terms and conditions :-

Conditions for IPD Treatment

- (i) No Direct Treatment is admissible except the case is considered in the merit of EMERGENCY and if referred by the CGHS Wellness Centre or any other Govt. Hospital/AIIMS. The procedure of IPD/admission for treatment of beneficiary is to be regulated in accordance of OM dated 10.12.2018 without permission letter of NCERT.
- (ii) Emergency Certificate is to be issued by the Hospital while sending the medical bills.
- (iii) That all the terms and conditions of agreement executed in between your hospital/diagnostic/labs centre and Additional Director, CGHS will remain unchanged and rates subsequently notified by CGHS from time to time would also be applicable.
- (iv) The agreement of contract/the extension of the facilities shall remain enforce valid up to the date of contract it is modified /revoked by the CGHS or NCERT.
- (v) The cost of non-reimbursable items will be charged from the pensioners/Serving employees by the Hospital itself. NCERT will not in any manner pay the amount of non-reimbursable items to the Hospital/diagnostic centre.
- (vi) In light of GOI, MHFW OM No.15025/117/2017/DIR/CGHS/EHS dated 15.01.2018, all CGHS beneficiaries shall be permitted for seeking OPD consultations from specialists at Private Hospitals empanelled under CGHS after being referred by any Medical officer/CMO of CGHS wellness centre. The referral may be mentioned on the computer generated prescription slip.
- (vii) In case of non-listed investigations/treatment procedures, permission from the NCERT is required to be taken by the beneficiary.
- (viii) Permission for follow-up treatment shall be required from the NCERT.
